EXPLANATION

This document is a legal waiver. Please read it in full. By participating in exhibitions conducted by the Exhibition Poultry Association of NSW Inc – no. 3476100 and its affiliated member clubs listed below (the Association), you agree to the contents of this waiver. It means that you are surrendering (giving up) any legal rights you may have against the Association and others for compensation in the event that you are injured, suffer an illness, die, or suffer property damage even if the Association or its office bearers are at fault.

All Participants participate in poultry exhibitions and all associated activities (“exhibitions”) at their own risk and on the following terms and conditions:

1. Participants warrant to the Association and agree that they are not aware of any illness, injury, physical disability, or impairment which may cause them illness, injury, or death during or as a consequence of participation in exhibitions conducted by the Association.
2. The decision to participate is entirely the decision of each participant and each participant accepts all risks associated with participation in exhibitions, including but not limited to infection from a communicable disease, loss of life or permanent injury, disease or death of poultry and loss or damage to property.
3. The Association will not be liable to you for any alleged breach of an express or implied warranty that services provided by the Association will be provided with reasonable care and skill.
4. Each participant releases the Association and its office bearers from all claims, **including claims for negligence**, demands and proceedings arising out of their participation in exhibitions conducted by the Association and indemnifies the Association, and its office bearers against all liability, loss or damage arising out of their participation **including liability for negligence**. This release extends to agents, contractors, employees, promoters, sponsors, and volunteers, involved directly or indirectly with exhibitions in any manner whatsoever. This release and indemnity continue forever and binds the participants, their heirs, executors, personal representatives, and assigns.
5. Where the participant is under the age of 18, the parent or guardian of that participant, accepts these terms and conditions and the waiver on behalf of the participating minor.
